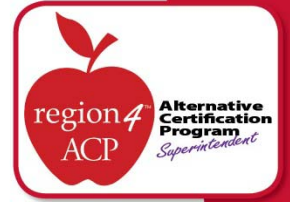

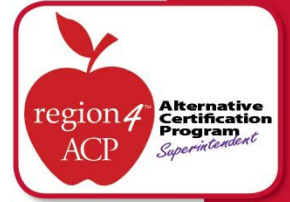

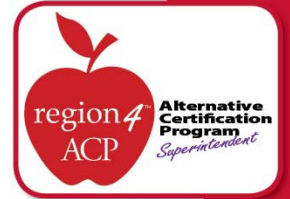
# Training Focus



- Training sessions and coursework are based on the standards for the Superintendent Certificate as described in the Texas Administrative Code. These standards are also the basis for the Superintendent TExES competencies and are included in this program.
- Each intern receives over 200 hours of instruction, plus a minimum of 160 hours of field-based internship activities.
- At the intern's option, six (6) semester graduate hours may be earned through the University of St. Thomas (UST) as part of the program.



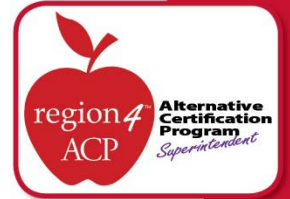
# Program Delivery



- The Region 4 Superintendent Certification Program offers both blended and online instructional delivery tracks, plus field-based preparation for aspiring superintendents and district level administrators.
- The intent of the program is to integrate theory and practice through on-the-job internship assignments, required readings, reflective seminars, research and role responsibilities.
- Each intern will develop—in collaboration with a Region 4 field supervisor and district mentor—a Professional Proficiency and Certification Plan (PPCP) detailing the training and field-based experiences that must be completed by the intern in order to promote professional growth.



# Program Delivery, Cont.



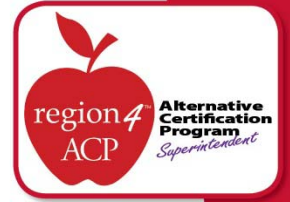
- Training will be individualized to meet the needs of each intern as determined by the individual assessment process and as recorded on the PPCP.
- All training will be coordinated through Region 4 in conjunction with school districts and charter schools.
- As much as possible, training will be delivered to each group of interns as a cohort to allow for networking and the development of a support system.



# Training Seminars and Sessions

**Examples of superintendent competencies and program topics are:**

- Leading the educational community with vision, ethics, collaboration, and fairness.
- Responding to the larger political and social climate, including the Board of Trustees.
- Strategic planning to enhance teaching and learning.
- Sustaining a culture of student learning and professional growth.

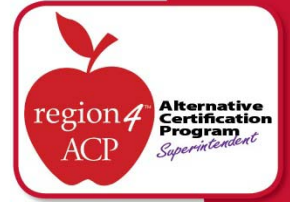


# Training Seminars and Sessions, Cont.

- Understanding legal and ethical responsibilities.
- Organizational decision-making and problem solving.
- Achieving the superintendent's position.



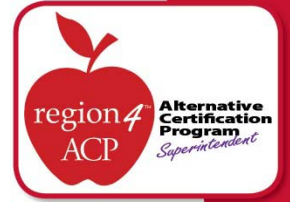
# Entry Requirements



- Hold the Texas Standard Principal or Mid-Management Certificate.
- Have a minimum GPA of 3.0 in a master's or other advanced degree program.
- Provide a letter of reference and support from your superintendent or designee for program participation.
- Demonstrate leadership skills in professional and community activities and currently hold a school/district leadership position.



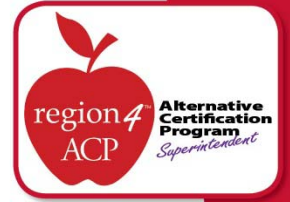
# Application Process



- Submit a completed application online.
- Mail or bring the following items to Region 4 (no partial packets, please):
  - Official transcripts indicating your master's degree. Transcripts must be mailed to Region 4 from the university or provided in the original sealed envelope from the university.
  - For candidates with degrees from outside of U.S., a transcript evaluation from a recognized transcript evaluation company must accompany the application. In addition, Region 4 ACP requires verification. Please see website for details regarding international credentials.
  - Copy of valid standard Principal or Mid-Management certificate.
  - A letter of reference and support for program participation and the field based experience from your superintendent or designee on district letterhead.



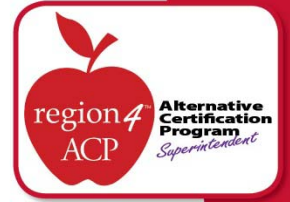
# Admission Process



- Initial screening includes a review of official transcripts, completed application, Texas Principal or Mid-Management Certificate, and letter of support from the superintendent or designee.
- Final selection is made with input from Region 4 program coordinators and superintendent reference.
- Program cycle begins September 2010; application deadline is September 10, 2010.



# Program Costs and Payment Schedule

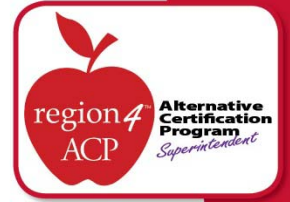


- Program Fee (Blended and Online Track) - \$4140.00
  - Program fees payable by monthly auto-draft deductions or advance payment.
- \$20.00 processing fee charged at beginning of internship.
- Required textbook: *Superintendent Leadership*, Elaine L. Wilmore, Corwin Press, ISBN: 978-1-4129-5541-6 (pbk.)
- Superintendent TExES - \$240.00
- SBEC application fee for the Standard Superintendent Certificate - \$77.00

# Optional Costs



- Six Semester Hours UST course credits - \$350.00 per course (Superintendency; Superintendent Internship).
- Probationary Superintendent Certificate (SBEC) - \$52.00 for one year certificate.
- Aspiring Superintendent Academy fee for Online Track participants - \$590.00 value added option for all six sessions or \$125.00 for selected individual sessions.
- Recommended (optional) textbook: *Passing the Superintendent TExES Exam*, Elaine L. Wilmore, Corwin Press, ISBN: 978-1-4129-5619-2 (pbk.).

NOTES: Aspiring Superintendent Academy is required in the Blended Track Program and included in that program track's cost.

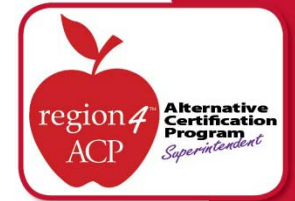

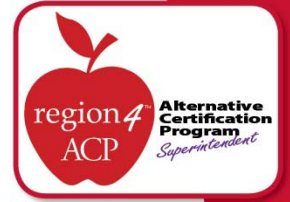

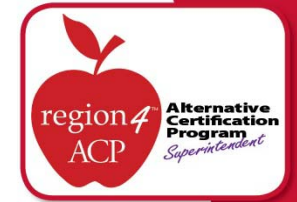

# Certification

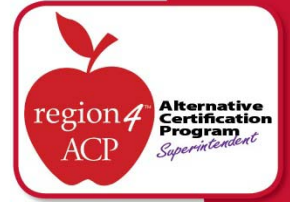


To be recommended for standard certification:
