- Were Social Studies materials discussed at the SBOE meeting? Proclamation 2014 (Science) was discussed, but not much was said concerning the 2015 Proclamation (Social Studies). Information is currently going out to publishers concerning our TEKS which the publishers can use to submit their resources for review. The TEA review of these resources will take place next summer.
- What discussion is taking place concerning the combination World Geography and World History course? What can we do to prepare? Julie has no information about it yet but she will share information as it becomes available.
- Personal Financial Literacy: Will this course be required in addition to Economics or instead of Economics? That decision has not yet been made by the SBOE. Personal Financial Literacy content should be taught in Economics for this year until more information is available.
